**INTRODUCTION OF DOTSAIDIA-DOTSHULE OFFER TO LEVERAGE
ICT FOR EFFECTIVE IMPLEMENTATION OF THE NEW LOWER
SECONDARY CURRICULUM**

We have received a request from M/s dotSaidia Systems Limited to use the Ministry's Channels of Communication to reach out to the entire School Community for Equal dotShule Opportunity in a campaign for effective implementation of the New Lower Secondary Curriculum. The Company developed a locally integrated Online School Management Information System platform code named dotShule which integrates day to day Teaching and Learning activities including automation of School Management Processes and Functions.


The National Curriculum Development Centre (NCDC) approved the dotShule Online Material/System to support the implementation of the New lower Secondary Curriculum for a period of two years (January 2023 – December 2024) as per Certificate No. CD/2022/98 (copy attached).

The Company offers dotShule under premium plan at a cost of UGX 7,500,000 for system setup and UGX 10,000 per student per year for sustainability. However, in an effort to serve schools equitably, they will provide dotShule Management Modules for the New Lower Secondary Curriculum to Schools at no charge for the Academic Year 2023. Under this, all Government and Private Secondary Schools with Operational Computer Laboratories or at least two Computers will benefit. After this, the School will be required to pay UGX 1,500,000 per year as ground fee.

The Company has also automated School enrolment process and in this, system processes will cost UGX 150,000. To get connected, a School visits <https://dotshule.ug/connection>.

The purpose of this letter therefore, is twofold:

1. To introduce to you the Company dotSaidia Systems Limited and their School Management Information System – dotShule.
2. To request you to allow the Company to demonstrate to you the dotShule System to enable you make an independent decision on whether to take it on, should it fit within your plans and resources.

In accordance to our recent engagement with the Ministry of Education and Sports, Dotsaidia Systems Ltd has reduced the dotShule connection cost from 250,000/= to 150,000/=.
